अनुसूचित जाति एवं अनुसूचित जनजाति के छात्र/छात्राओं को तकनीकी, व्यवसायिक एवं प्रोफेशनल कोर्सों में निजी संस्थाओं में प्रवेशिकोत्तर छात्रवृत्ति योजना के अन्तर्गत लाभ प्रदान करने के लिये राज्य सरकार द्वारा ऐसे निजी संस्थाएँ जिनके द्वारा तकनीकी, व्यवसायिक एवं प्रोफेशनल संचालित किया जा रहा है तथा जिस संस्था में आवासीय सुविधा उपलब्ध है, के लिये विभिन्न समाचार पत्रों एवं विभागीय वेबसाईट के माध्यम से इम्पेनेल करने के निमित्त Expression of Interest प्रकाशित किया गया है ।

उक्त के आलोक में Expression of Interest में उल्लिखित शर्तों के अनुसार विभिन्न संस्थाओं द्वारा इम्पेनेल करने के लिये प्रस्ताव समर्पित किया गया है । तृतीय चरण (3<sup>rd</sup> Phase) में Expression of Interest में उल्लिखित शर्तों के आलोक में निम्नांकित शर्तों के अनुसार संलग्न सूची में उल्लिखित संस्थाओं को औपबंधिक (Provisional) रूप से इम्पेनेल करने का निर्णय लिया गया है:-

- 1- संस्थाओं का इम्पेनेलमेंट पूर्णतः औपबंधिक रूप से किया जा रहा है ।
  - 2- औपबंधिक रूप से इम्पेनेल संस्थाओं का भौतिक सत्यापन बाद में विभाग द्वारा कराया जायेगा ।
  - 3- Expression of Interest में उल्लिखित शर्तों में कोई भी कमी पाये जाने पर इम्पेनेलमेंट को निरस्त किया जायेगा तथा संस्था द्वारा जमा राशि (Security Deposit) को जब्त किया जायेगा ।
  - 4- छात्र/छात्राओं को दी जाने वाली शुल्क संबंधित संस्था जिस राज्य में अवस्थित है उस राज्य सरकार द्वारा निजी संस्थानों के लिये फी निर्धारण समिति द्वारा निर्धारित शुल्क के अनुसार ही भुगतान किया जायेगा ।



No interest what so ever will be payable to the institutions.
